

T-Bills are issued at a discount to the Face Value.

Treasury Bonds are long term gilt-edged instruments issued by the Central Bank of Sri Lanka with maturities ranging from 02 to 20 years or more. They are ideal investments for investors seeking long term assets and in capitalising on anticipated declines in interest rates. Bonds offer bi-annual coupon interest payments to the holder.

INVESTMENT SOLUTIONS WITH FLEXIBLE DURATIONS REPURCHASE AGREEMENTS (REPOS)

Repos are issued by primary dealers / banks for predetermined periods when they wish to borrow funds from investors against the collateral of T-Bills and T-Bonds. Repos can be invested in for periods ranging from 01 day to 12 months or more and are ideal instruments for short term investments with flexible durations.

FACILITATIVE SERVICE REVERSE REPURCHASE AGREEMENTS (REVERSE REPOS)

Investors with portfolios of Treasury Bills / Bonds / Repos have the option to borrow for short term durations against their securities (subject to conditions). Reverse Repos are generally more cost effective than traditional bank borrowings.
