AGREEMENT FOR LANKASECURENET - TERMS AND CONDITIONS

The Monetary Board of the Central Bank of Sri Lanka, Central Bank of Sri Lanka, P.O.Box 590, Colombo 01.

Dear Sir/ Madam,

I/We..... of request you to issue me/us a User Identification Number (User ID) and allow me/us the use LankaSecureNet, Internet Based Account Verification Facility and hereby agree to be bound by the following terms and conditions:

1. Facility

I/We acknowledge and accept that the facility available to me/us under this agreement is to view my/our personal scripless securities account in the central depository system of the Central Bank of Sri Lanka through the use of operational instructions as contained in the user guide annexed hereto.

have absolute discretion to change, vary, add or amend these privileges and conditions attached thereto, from time to time as the LankaSecureNet deems necessary.

- c) LankaSecureNet may time to time introduce new facilities/options into LankaSecureNet service. I/We hereby agree to abide by the terms and conditions applicable to such newly added services, facilities/options though added subsequently to the activation of the User IDs whether or not I/We register myself/ourselves to avail such services.

2. Responsibilities for Security.

- a) I/We agree to duly acknowledge the receipt of my/our Password and also agree to retain my/our User ID in disabled status till LankaSecureNet receives proper acknowledgement of receipt of the password by me/us.
b) I/We undertake not to access LankaSecureNet using defective or insecure equipment or in any manner which might adversely affect LankaSecureNet.
c) I/We hereby agree to change the password assigned to me/us immediately after accessing LankaSecureNet for the first time and at regular intervals thereafter.
d) I/We shall inform LankaSecureNet immediately if I/we become aware of any unauthorized access to or use of the User ID and Passwords by anyone. I/We acknowledge that the Monetary Board of the Central Bank of Sri Lanka shall not be liable for any loss or damage that I/we may suffer on account of any unauthorized use of my/our User ID and Password.
e) I/We shall keep my/our User ID and Password strictly confidential and undertake not to reveal them to any person at anytime or under any circumstances.
f) I/We shall keep all information, techniques, data and designs relating to LankaSecureNet completely confidential. I/We shall not disclose any of them to any other party.
g) My/Our obligations relating to confidentiality will continue indefinitely. They will not end with the expiry or termination of this agreement.

4. Indemnity

I/We do hereby agree and save harmless against any losses, charges, expenses and damages that LankaSecure shall or may be caused or sustain incur or suffer by reasons of my/our using LankaSecureNet in any manner whatsoever and for any loss and/or misdirection of data in transit electronically and by reasons of LankaSecure generating and/or issuing and/or dispatching the original password/s according to my/our requests and/or subsequent passwords to my/our User ID, at my/our written request and any substitution effected by me/us or by reason of access to my/our password or ID number by any person other than me/us.

5. Governing law

This agreement shall be governed and construed in accordance with the laws of Sri Lanka.

I/We have read and understood the forgoing and agree to be bound by the above terms and conditions and the Indemnity.

3. Changing the Terms and Conditions.
