**AGREEMENT FOR LANKASECURENET -
TERMS AND CONDITIONS**

User Identification Number (User ID) and allow us the use LankaSecureNet, Internet Based Account Verification Facility and
hereby agree to be bound by the following terms and conditions:

1. Facility

We acknowledge and accept that the facility available to us under this agreement is to view our scripless securities account in the central depository system of the Central Bank of Sri Lanka through the use of operational instructions as contained in the user guide annexed hereto.

2. Responsibilities for Security.

- a) We agree to duly acknowledge the receipt of our Password and also agree to retain our User ID in disabled status till LankaSecureNet receives proper acknowledgement of receipt of the password by us.
- b) We undertake not to access LankaSecureNet using defective or insecure equipment or in any manner which might adversely affect LankaSecureNet.
- c) We hereby agree to change the password assigned to us immediately after accessing LankaSecureNet for the first time and at regular intervals thereafter.
- d) We shall inform LankaSecureNet immediately if we become aware of any unauthorized access to or use of the User ID and Passwords by anyone. We acknowledge that the Monetary Board of the Central Bank of Sri Lanka shall not be liable for any loss or damage that we may suffer on account of any unauthorized use of our User ID and Password.
- e) We shall keep our User ID and Password strictly confidential and undertake not to reveal them to any person at anytime or under any circumstances.
- f) We shall keep all information, techniques, data and designs relating to LankaSecureNet completely confidential. We shall not disclose any of them to any other party.
- g) Our obligations relating to confidentiality will continue indefinitely. They will not end with the expiry or termination of this agreement.

3. Changing the Terms and Conditions.

- a). LankaSecureNet shall at any time be entitled to amend, supplement or vary any of these terms and conditions at its absolute discretion with or without notice to us and such amendment supplement or variation shall be binding on us.

- b) LankaSecureNet shall determine the privileges attached to the use of LankaSecureNet and shall have absolute discretion to change, vary, add or amend these privileges and conditions attached thereto, from time to time as the LankaSecureNet deems necessary.
- c) LankaSecureNet may from time to time introduce new facilities/options into LankaSecureNet service. We hereby agree to abide by the terms and conditions applicable to such newly added services, facilities/options through added subsequently to the activation of the User IDs whether or not we register ourselves to avail such services.

4. Indemnity

We do hereby agree and save harmless against any losses, charges, expenses and damages that LankaSecure shall or may be caused or sustain incurr or suffer by reasons of our using LankaSecureNet in any manner whatsoever and for any loss and/or misdirection of data in transit electronically and by reasons of LankaSecure generating and/or issuing and/or dispatching the original password/s according to our requests and/or subsequent passwords to our User ID, at our written request and any substitution effected by us or by reason of access to our password or ID number other than a person authorized by us.

5. Governing law

This agreement shall be governed and construed in accordance with the laws of Sri Lanka.
